
Ethics review

- Ethical norms of science
 - Norms for seeking scientific truth and judging the reliability of research
 - Norms for protecting human dignity
 - Norms connected to relationships between researchers
- Used in medicine already since the end of the 1960s
- Realised by an impartial and independent body
- Research plan and supplementary material are subjected to review
 - Ethical acceptability of the research
 - Status and rights of research subjects (voluntariness, approval, informing)
 - Potential risks and disadvantages compared to advantages

HYMY II

1.11.2007 - 31.12.2008

- Need for ethics review
 - International publication, foreign sponsor, or foreign research partner requires the review
 - Competence and capacity of hospital district ethics committees are not adequate
 - Researcher him/herself needs the support gained through the review for conducting his/her study
 - "But do we even know what kind of harm participating in a research process might bring to the individual or his/her family?" Sakari Karjalainen 2006 → Research subjects need protection
